\*Any attempted visits will be charged full price.

\_\_\_\_ Please notify your veterinarian of your absence and make arrangements for care in case of emergency. Any veterinarian costs incurred during Service Dates will be charged to the Client. “Going to the Dogs” will make all efforts to get your pet(s) the emergency care they need as quickly as possible. You will be notified immediately in case of emergency.

\_\_\_\_ In case of emergency (vet, burglary etc.), extra service time not specified in Service Contract incurred during your absence will be charged at \$25 per hour.

\_\_\_\_ Please note that “Going to the Dogs” will not allow unknown Third Parties into your house unless specifically requested by Client. If Third Party is persistent, “Going to the Dogs” will call you at your contact number before letting anyone into the house. Client will not hold “Going to the Dogs” responsible for theft of or damage to property if a Third Party has access to the house at the same time of the Service Dates. We do our best to take care of your property and leave your house in the same condition as when you left. If property is damaged by “Going to the Dogs,” we will notify you upon your return and will work with you to remedy the situation.

\_\_\_\_ If Client agrees to letting pet(s) have access to the outside during Service Dates, Client will not hold “Going to the Dogs” responsible for death of pet(s). We will do everything to ensure that your pet(s) stay safe during our Service Times. If a death does occur, you will be notified immediately by “Going to the Dogs” about the situation.
